STREAMLINED RESOLUTION OF REQUESTS RELATED TO ACTIONS BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

CC Docket No. 02-6

Pursuant to our procedure for resolving requests for review, requests for waiver, and petitions for reconsideration of decisions related to actions taken by the Universal Service Administrative Company (USAC) that are consistent with precedent (collectively, Requests), the Wireline Competition Bureau (Bureau) grants, dismisses, or denies the following Requests.¹ The deadline for filing petitions for reconsideration or applications for review concerning the disposition of any of these Requests is 30 days from release of this Public Notice.²

that the funding requests were correctly approved for 24 months of support. For FRN 14573121, Northland confirmed in correspondence with USAC that the funding request was correctly approved for 26 months of support. For FRN 15703081, based on the service start date, the funding request was approved for 29 months of support. For FRN 15764641, based on the service start date, the funding request was approved for 28 months of support. If Northland believed its funding requests should have been approved for 36 months of support – notwithstanding its written confirmations to USAC to the contrary and the service start dates on the FCLs – it was required to first appeal the funding decisions to USAC within 60 days from the dates USAC issued its funding decisions, not the Commission. 47 CFR § 54.719(a)-(b); *see Request for Review of a Decision of the Universal Service Administrator by La Canada Unified School District; Schools and Libraries Universal Service Support Mechanism*, CC Docket No. 02-6, Order, 30 FCC Rcd 4729, 4729, para. 2 (WCB 2015) (dismissing an appeal that properly belonged before USAC pursuant to Commission rules within 60 days from the dates that USAC issued the FCLs). Northland did not submit an appeal regarding the funding decisions on its FY2014 and FY2015 funding requests to USAC at all, however, and its deadline to do so has long passed. 47 CFR § 54.720(a) (requiring a party requesting review or waiver of a USAC decision to file such request within 60 days from the date that USAC issues a decision). Northland has not articulated special circumstances for waiving the 60-day appeal deadline in its request for review and waiver to the Commission. Northland asserts that, due to USAC’s delay in processing the invoicing forms (FCC Forms 463), it did not realize until the invoices were approved that the five FRNs were not funded for 36 months of service. The scope of the funding approved by USAC was stated in the FCLs issued by USAC in 2015 and 2016, however. Failure to carefully review FCLs and understand program rules and procedures are not grounds for waiving the FCC’s rules. *See Request for Review of the Decision of the Universal Service Administrator by School Administrative Unit 41*, CC Docket 02-6, Order, 20 FCC Rcd 2175, 2176, para. 2 (WCB 2005) (declining to waive the appeal deadline because “[e]mployee misunderstandings about whether an application was approved . . . do not relieve applicants of their responsibility to understand and comply with the program rules or procedures”); *Requests for Review of Decisions of the Universal Service Administrator by Agra Public Schools I-134*, CC Docket 02-6, Order, 25 FCC Rcd 5684, 5687-88, paras. 4-6 (WCB 2010) (declining to waive the appeal deadline due to inattention, including a failure to fully read a funding commitment decision letter); *Request for Review of the Decisions of the Universal Service Administrator by Harmony Science Academy*, CC Docket No. 02-6, Order, 20 FCC Rcd 1298, 1299 para. 2 (WCB 2005) (declining to waive the appeal deadline due to a misunderstanding of the FCC’s rules and procedures).
