Re: Administrator FY 2011 Funding Denials for  
Untimely Filed Item 21 Attachments  
CC Docket No. 02-6

Dear Ms. Dortch:

On January 18, 2012, the State E-Rate Coordinators' Alliance ("SECA") filed a Request for Review and Waiver with the Commission with respect to E-rate funding denials by the Universal Service Administrative Company ("USAC") for untimely filed Item 21 attachments on FY 2011 Form 471 applications. SECA's filing:

- Noted that the submission of Item 21 attachments with the associated Form 471 applications was a new requirement for FY 2011.
- Noted also that, while USAC issued approximately 15,000 urgent reminder letters to applicants who might have missed the Item 21 attachment deadline, the warning process was flawed and highly confusing to applicants.
- Requested that the Commission provide omnibus (or blanket) waiver of the FY 2011 Item 21 attachment filing deadline so that missing attachments could be treated as routine PIA inquiries.
- Included a list of nineteen applicants whose applications had been denied, in whole or in part, on the basis of untimely filed Item 21 attachments.

On May 31, 2012, the Wireline Competition Bureau released an Order, DA 12-855, granting Item 21 attachment deadline waivers on behalf of the nineteen listed applicants and remanding the affected applications to USAC.<sup>1</sup>

Unfortunately, the WCB Order did not address SECA's request for a blanket waiver. As a result, many more applicants have been denied funding for the same reason in later waves. The two attachments to this filing list the current total<sup>2</sup> — 159 as of Wave 50 — of FY 2011 applicants who have been denied funding for one or more FRNs for missing or untimely filed Item 21 attachment. In dollar terms, these denials represent over \$5.5 million in lost funding for these applicants. Attachment A lists the applicants by Form 471 application numbers and, in each case, shows examples of the denial reasons cited. Attachment B lists the specific FRNs denied. Note that both attachments list (highlighted in yellow for completeness) the seven applicants whose denials were remanded to USAC in DA 12-855.

SECA continues to urge the Commission to issue a blanket waiver for untimely-filed Item 21 attachments for FY 2011. Such a waiver would provide relief, consistent with DA 12-855, for the additional 151 applicants listed in this filing, as well as for other applicants who may otherwise be denied for similar infractions in subsequent funding waves.
